“Student Grant” 2020/21

Dear Parents/Guardians,

The Education Bureau has announced the implementation of the “Student Grant” 2020/2021 which is a non-means-tested, one-off student grant of \$2,500 for each secondary day-school student.

For the “Student Grant” Application Forms, there are Form A and Form B. **Form A** is a blank form (applicable to students who are newly admitted to a school in this school year or have transferred to another school). **Form B** is pre-printed with the basic information of the student as well as that of the applicant (applicable to students who have been promoted to the next class level in the same school) Parents should base on the above situation to complete a “Student Grant” Application Form.

If the pre-printed information on Form B requires updating (except Student’s Name in English, Name of Day-school and School Level), parents/guardians have to provide the amendment(s) in the space above the relevant information in BLOCK letters using **black or blue ball pen, leave the confirmation box blank** and submit the application forms to the EDB through schools. If you need to fill in **Form A**, you may refer to following bank information to complete the form.


